- **Item No. 5** To inform about Increase in Intake, Merger of Courses for A. Y. 2025-2026.
- **Resolution No.5** Hon. Director discussed the proposed increase in student intake for the Academic Year 2025-26 for the following programs:
 - 1. Computer Science and Engineering (Artificial Intelligence and Machine Learning): Intake to be increased from 60 to 120.
 - 2. **B.C.A.** (**Bachelor of Computer Applications**): Intake to be increased from 40 to 60.

Additionally, he informed that the **MBA** (**Innovation**, **Entrepreneurship**, **and Venture Development**) program, with an intake of 30 students, has been merged into the general **MBA** program. Consequently, the total intake for the MBA program has been revised to 150 students.

Item No. 6 To inform about new courses and Increase in Intake for A. Y. 2024-2025.

Resolution No. 6 Hon. Director shared updates regarding new courses and changes in intake for the Academic Year 2024-2025, as detailed below:

New Courses and Intake:

- 1. **BBA** (Bachelor of Business Administration): Intake of 120 students.
- 2. **BCA** (Bachelor of Computer Applications): Intake of 40 students.
- 3. MCA (Master of Computer Applications): Intake of 60 students.
- 4. **Mechatronics (Diploma):** Intake of 60 students.

Increase in Intake for B.Tech Programs:

- 1. **Robotics and Automation:** Intake increased from 30 to 60 students.
- 2. **Computer Engineering:** Intake increased from 120 to 180 students.

Hon. Director also announced the following changes:

- 1. Closure of the Diploma in Automobile Engineering, which had an intake of 30 students.
- 2. Merger of the Diploma in Computer Hardware and Maintenance (intake of 30 students) with the Diploma in Computer Engineering (intake of 120 students). As a result, the revised intake for the Diploma in Computer Engineering is now 150 students.

He further shared that from A.Y. 2024-25 we started twinning programs and collaboration as per the details mentioned below –

Hon. U. Chandrasekhar suggested that faculty need to be trained for Diploma Robotics & Automation as far as NEP is concerned. Hon. Director added that we have received a CSR fund of 1.5Cr to develop our Robotics & Automation laboratories.

- Item No. 7 To inform about recent NBA committee result and update about upcoming NBA committee visit.
- **Resolution No. 7** Hon. Director informed that the NBA committee visited the campus from December 6th to 8th, 2024, for the accreditation of the Civil PG Structural Engineering program. The result of the accreditation process is currently awaited.

He further stated that the NBA Compliance Committee is scheduled to visit the RIT campus in March/April 2025 for the continuation of accreditation status for the following undergraduate programs:

- 1. Electronics and Telecommunication Engineering
- 2. Electrical Engineering
- 3. Computer Science and Engineering

Additionally, the Hon. Director informed the attendees that, in the upcoming NBA cycle, the following Post Graduate programs have been applied for NBA accreditation:

- 1. MBA
- 2. Electronics Engineering
- 3. Mechanical Engineering (Thermal Engineering)

He further added that the pre-qualifiers for these programs have been accepted by the NBA, and the Self-Assessment Report (SAR) is currently being completed.

- **Item No. 8** To discuss about R & D updates & AICTE Idea Lab.
- **Resolution No. 8** Hon. Director informed to the BOG members about the inauguration of Startup TGP Bioplastic Pvt. Ltd. He further emphasized that it was a privilege to host an inspiring lineup of esteemed guests, including:
 - Dr. Anil Kakodkar, Chairman, RGSTC
 - Dr. J. B. Joshi, Chancellor, ICT Mumbai
 - Dr. Rajesh Pathak, Secretary, Technology Development Board
 - Mrs. Bineesha P., Executive Director, IIWM

Following this, Dr. A. B. Kakade presented the status of paper publications for the academic year 2023–2024. He reported that:

- The number of publications in Scopus/Web of Science Indexed Journals is 99.
- The number of publications in Journals on Engineering Education is 27.

Dr. A. B. Kakade, Dean R&D further added that 88 patents are filed and 12 patents are under filing. He briefed about the Seed Funding Project titled "Design and Development of Seed Ball Dropping Attachment" which has received funding of Rs. 4,95,000/- from RGSTC, Shivaji University, Kolhapur.

Dean R&D also provided an update on ongoing research projects, which include:

- Sugarcane Leaf Removing Machine
- IoT-Based Motor Control and Protection Unit
- Automatic Bottle Capping Machine
- A Low-Cost Ventilator
- Automatic Garlic Peeling Machine
- Magnesiothermic Reduction of CO2 for Graphene Synthesis
- Synthesis of Low-Density Polyethylene (LDPE) from Ethanol

Additionally, he shared information about various research proposals submitted under different schemes from June 2024 onwards. Regarding sugarcane leaf removing machine, Hon. U. Chandrasekhar informed that there is a research grant from Technology Development Fund. He further added that whenever we got a product which has a wide range of commercial applications, we can apply for this research grant.

Mr. Harshal Patil, CEO of NETRA-RIT presented the newly developed product named Shwas Ventilator, Hon. U. Chandrasekhar suggested to take the Entrepreneurship in Residency (EIR) consultancy.

Dr. R. M. Kurane presented Magnesiothermic Reduction of CO2 for Graphene Synthesis. Hon. U. Chandrasekhar suggested to connect with Ministry of Information Technology in this regard.

Mr. Harshal Pati explained about NRIT funding and the details are as mentioned below

- MSME 65.5 lakhs
- Maharashtra State Innovation Society Rs. 5 Cr.
- DST NIDHI Rs.3.5 Cr.
- SARATHI Rs.36 Lakhs
- HDFC Bank PARIVARTAN Rs.25Lakhs

In this regard, to leverage additional funding opportunities, it has been suggested by Hon. Jayant Patil Saheb that faculty members explore external opportunities and collaborations. This initiative aims to enhance research and project funding for the institution.

The BOG members extended their heartfelt congratulations to the Hon. Director and the Research Team for their significant contributions to research projects and their continued dedication to innovation and excellence.

Item No. 9 To inform about Admission status of A.Y. 2024-2025

Resolution No. 9 Hon. Director presented the admission status for A.Y. 2024-2025 for B.Tech, M.Tech, BBA, MBA, BCA, MCA and Diploma programs. He informed that the total admissions for B.Tech against actual intake are 98.33% and 114.61% considering over and above admissions. He further added that the admissions for M.Tech are 86.48% and 102.83% considering over and above admissions. For MBA and MBA(IEV) there are 100% admissions against actual intake and 115.33% considering over and above admissions. For Diploma courses, admissions are 100% and 115.12% considering the admissions against actual intake and over and above admissions respectively. For BBA, BCA and MCA programs the admissions are 63%, 80% and 99.5% respectively. He also added that total 7 students are admitted through Foreign National quota from Nepal, Zimbabwe and Bangladesh. He further informed that 1 student is admitted through Jammu & Kashmir quota for direct second year of Civil Engineering. Hon. Chairman suggested that during the last admission round, we can extend offers to meritorious students who are likely to be admitted to other colleges like Walchand College of Engineering. To retain these students, we can bear the difference in fees between RIT and Walchand College. This strategy can help us to attract and retain top talent, enhancing our institution's reputation and percentage of admissions.

To expand our institution's global footprint and students' diversity, the Chairman has suggested exploring innovative strategies to attract international students and students from outside Maharashtra. This initiative aims to enhance our reputation as a premier educational institution and foster a more diverse and inclusive learning environment.

All members of the Board of Governance congratulated the Hon. Director and his team for achieving successful admissions.

Item No. 10 To present and discuss about Annual budget for F. Y. 2024-2025

Resolution No. 10 Hon. Director presented the annual budget for the financial year 2024-25, considering the actual admissions. The financial details for various programs are as follows:

B.Tech & M.Tech:

• Total Income: ₹44,70,00,000/-

Total Expenditure: ₹41,40,00,000/-

• Surplus: ₹3,30,00,000/-

MBA:

• Total Income: ₹3,24,00,000/-

• Total Expenditure: ₹3,18,00,000/-

Diploma:

• Total Income: ₹5,36,00,000/-

The budget reflects a positive financial outlook with overall surpluses across most programs, except for BCA, which recorded a deficit.

Item No. 11 To inform about fees sanctioned by FRA.

Resolution No. 11 Hon. Director provided an update on the fees sanctioned by the Fee Regulating Authority (FRA) for the academic year 2024-25. He announced that the sanctioned fee for the **B.Tech** program is ₹1,57,000/-, reflecting an increase of ₹17,000/- compared to the previous year. For the **M.Tech** and **MBA** programs, the institution opted for a "No Upward Revision" policy, keeping the fees unchanged at ₹86,500/- and ₹96,000/-, respectively.

He also presented details of expenditures not considered by FRA and informed that an **appeal has been submitted** regarding the fee declared for the **Diploma** program. For the **Diploma** program, the sanctioned fee is ₹46,120/-, which marks a **marginal increase of** ₹120/- compared to last year. The **MCA** program has been assigned an **ad hoc fee of** ₹90,000/-. Meanwhile, the fees for **BBA** and

BCA programs have been finalized at the **institutional level** at ₹40,000/- and ₹55,000/-, respectively.

Item No. 11a. To decide the fees for AICTE approved BBA and BCA programs

Resolution No. 11 a. Hon. Director informed to the committee regarding the Fees fixation for newly approved BBA and BCA programs by AICTE. He further added that UGC has mentioned in clause no. 3.7 in their guidelines ('Conferment of Autonomous Status upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges Regulations, 2023') dated 03/04/2023, that 'Autonomous Colleges may fix fees as per the norms of the State Government/ Statutory Council(s) at their own level, as applicable' and also as per the Shivaji University statutes framed under section 51 of the Act, October 2013, it is mentioned that 'Their shall be a Fee Fixation Committee to work out the real cost of delivery of each and every undergraduate and post graduate courses or programs run by the University, colleges and recognized Institutions other than Autonomous colleges and Autonomous Institutions and those managed and maintained by the State Government, Central Government and local authorities'.

As per the UGC and Shivaji University guidelines regarding fee fixation, it was decided that the fees for newly AICTE approved BBA and BCA programs should be finalized at the institutional level, considering the proposed expenses for recurring and capital expenses. The details of the final approved fees are as follows.

Item No. 12 To discuss about ongoing Infrastructural Developments and future requirements.

Resolution No. 12 Hon. Director provided an update on the ongoing and proposed construction projects within the institution.

He detailed the progress of the **new academic building**, which consists of **Ground + Six floors**, with a total **built-up area of 65,000 sq. ft.** and an estimated cost of ₹12.0 Crores. All civil works have been completed, with only lift installation remaining. Currently, G+4 floors are occupied for academic purposes.

Additionally, he shared updates on the **new Gymnasium building**, which has a total built-up area of 31,593 sq. ft., with Phase I covering 18,161 sq. ft. at an estimated cost of ₹4.25 Crores. He confirmed that Phase I is nearing completion.

The Director also discussed the construction of the International Hostel Building, designed to offer single and double occupancy rooms and a mess facility with a dining capacity of 1,000 students. The hostel consists of Ground + Four floors, with a total built-up area of 68,456 sq. ft., an estimated cost of ₹25 Crores, and a total capacity of 208 students. He announced that the inauguration of both the Gymnasium and International Hostel buildings is scheduled for February 17, 2025, by the Honorable Shri Nitin Gadkari, Minister of Road Transport and Highways of India.

Looking ahead, he outlined several proposed construction projects to support the institution's growth, including:

- A **new girls' hostel** to accommodate increasing demand.
- An additional floor on Academic Building 1, in response to new courses and increased intake.
- A separate building for the Diploma wing.
- A state-of-the-art auditorium with a seating capacity of 1,000-1,500.
- A **Research and Innovation Park** to foster academic and industrial collaboration.
- A dedicated **Training and Placement Office** to enhance student career opportunities.

These developments reflect the institution's commitment to expanding infrastructure to support academic excellence and student well-being.

Item No. 13 To inform about the Placement Statistics

Resolution No. 13 Hon. Director presented the placement data to the forum as of January 2025. He reported that for the **B.Tech** program, 210 students out of 492 have been placed, achieving a placement percentage of 42.68% to date, with an average package of ₹3.90 LPA.

Additionally, he provided placement statistics for other programs:

- BBA: 54.28% placement, with an average package of ₹2.40 LPA.
- MBA: 31.74% placement, with an average package of ₹8 LPA.
- Diploma: 70% placement, with an average package of ₹4.25 LPA.

The forum emphasized the need to improve both the placement percentage and the offered salary packages. It was also suggested that the institute recruit a full-time, dedicated Training and Placement Officer to strengthen placement efforts and enhance career opportunities for students.

Item No. 14 To inform about RIT's International Relations

Resolution No. 14 Hon. Director informed the forum about the newly initiated Twinning & Collaboration Programs, which have received Intake Approval starting from the Academic Year 2024-25. He highlighted that RIT is the first institute in Maharashtra to take this initiative for the following Undergraduate (UG) and Postgraduate (PG) programs:

Undergraduate (UG) Programs:

- **Civil Engineering** 30 seats
- Electronics & Telecommunication Engineering 30 seats
- **Electrical Engineering** 30 seats
- **Mechanical Engineering** 30 seats
- **Computer Engineering** 30 seats

Postgraduate (PG) Programs:

- Structural Engineering 6 seats
- Computer Science & Engineering 6 seats
- Electronics Engineering 6 seats
- Power Systems & Power Electronics 6 seats
- Design Engineering 6 seats
- Mechanical Engineering (Thermal) 6 seats
- Master of Business Administration (MBA) 60 seats

He further stated that **a total of 18 admissions** have been secured this year under these programs, with **11 students in UG programs and 7 in PG programs**. He also informed the forum about the **facilities available for foreign students**, including a **Counseling Cell** and a **Skill & Personality Development Centre**, aimed at supporting their academic and personal growth. Additionally, he provided an update on the institute's **international collaborations**, mentioning that **28 Memorandums of Understanding (MOUs) have been signed with international universities**. He further highlighted that **73 students have received international fellowships, internships, virtual internships**, enhancing their global exposure and learning opportunities.

Regarding the **Student Exchange Programs**, he shared the following key updates:

- 11 students from RIT's MBA program have been selected for the Student Exchange Program, out of which 6 students received a 100% academic fee waiver.
- The One-Semester Exchange Program is scheduled from 15th February to 30th June 2024 and will be conducted offline.
- Three students and one faculty member from the Mechatronics & Mechanical Department attended a 10-day Summer School at NUK from 30th July to 8th August 2024.
