- Dr. Satyajit R. Patil, Dean QA detailed about NAAC Institutional Grade Sheet and Graphical representation of QIM and QnM received from NAAC.
- Dr. Mrs. Sushma S. Kulkarni, Director RIT discussed about low scoring metrics and suggested to focus on low scoring metrics. Also she suggested to Dr. A. B. Kakade, Dean, R & D to find out the cause of low scoring in research and consultancy metric by comparing our data with the data of other NAAC A+ institutes. It was also discussed that the metrics related to students' internships, no. of PhD faculties and consultancies have scored very low that was unexpected.

- Dr. Satyajit R. Patil, Dean QA read out the recommendations given by NAAC Peer Team for the Quality Enhancement of the Institution.
- Mr. Sachin Shirgaokar, Industry representative, shared his industry practices for training their new employees. Also, he suggested to modify the existing Mechanical program as 'Mechanical and Forging Engineering' or to introduce sandwich program of 'Foundry and Forging Engineering' so as to fulfil the industries demands and also to deal with the less no. of admissions for Mechanical Engineering. He suggested to explore 9+3 pattern i.e. 9 months academics and 3 months of internship for the curriculum. After some deliberations, it was decided to explore the feasibility of this option for RIT curriculum.
- Mr. Nitin Dalvai, Alumni representative, assured to help alumni association in raising the alumni fund. Also he will be suggesting the agencies for getting CSR Funding.
