MINUTES OF MEETING

Dr. S. K. Patil, Secretary, Academic Council (AC) welcomed all the members of the academic Council and the meeting started with a permission of the chairperson Dr. Mrs. S. S. Kulkarni (Director-RIT). Dr. Sachin K. Patil put forth an agenda of 18th Academic Council Meeting.

Agenda Item No. 1: Introduction & Academics at RIT.

Hon. Director Dr. S. S. Kulkarni, introduced RIT to newly appointed Academic Council members. She put a glance on inception of RIT, achievements, recognitions, various UG & PG programs, Vision, Mission of institute and 38 Years growth journey of RIT. Dr. S. K. Patil presented academic practices at RIT. He mentioned practices followed in curriculum development, teaching-learning and evaluation of the students. All AC members appreciated the efforts taken in development of the institute. Mr. Nikhil Padate suggested to give some weightage for global recognition to students and assign some credits in curriculum in terms of internship in abroad, attending conferences, interaction with faculty at outside, attending exhibitions in foreign countries etc. Hon Director mentioned the limitations like financial issues but assured to think on this suggestion in terms of online learning and interactions.

- Mr. Abasaheb Kale suggested to arrange site visits at Metro Rail Projects in India to have better understanding of subject like Metro Rail Technology. Moreover, he assured to help to reach at concerned authorities to arrange visits.
- For Project Management Laboratory course, consider ongoing construction projects for evaluation of students. Try to give live exposure to students.
- Add some content regarding risks like natural calamities at Engineering sites for final year students. Help can be taken from experts from insurance sectors.



- Dr. S. H. Sawant suggested to modify the prerequisite sections of the course i.e. Engineering Management & Economics and he mentioned that, add specific names of prerequisite courses needed. Moreover, he suggested to keep two to three course outcomes instead of six or seven.
